

SUB: MANDATORY SUBMISSION OF INFORMATION BY SHAREHOLDERS

Re: PAYMENT OF INTERIM CASH DIVIDEND @10% TO SHAREHOLDERS FOR THE PERIOD ENDED 30TH JUNE 2018

Dear Shareholder,

This is with reference to our letter dated September 05, 2018 on the captioned subject.

We would like to reiterate that as per provisions of Sections 242 and 243 of the Companies Act, 2017 ("**the Act**") and the Companies (Distribution of Dividends) Regulations, 2017 ("**the Regulations**"), it is mandatory for all listed companies to pay cash dividends through electronic mode directly into the designated bank accounts of entitled shareholders, provided that the shareholders should submit the required information i.e. valid bank account details and identification number (Computerized National Identity Card Number for natural persons and Registration Number/NTN in case shareholder is a non-natural person) in compliance with the requirements. The Regulations enable listed companies to withhold cash dividends for those shareholders who will not provide the required information.

In view of the above, the subject Interim Cash Dividend as declared by Bank Alfalah Limited ("the Bank") for the 2nd quarter/half year ended 30th June 2018, shall only be paid through electronic mode (i.e. direct credit into the designated bank accounts) to those entitled shareholders whose valid and complete bank account details along with other relevant information will be available with the Bank.

Therefore, in order to comply with the aforesaid mandatory requirements, kindly fill in and complete with valid information in the below mentioned form, put your signature thereon and submit the same in original along with a legible copy of valid CNIC to your CDC Participant (Broker)/Investor Account Services, if you hold shares of the Bank in electronic form, OR to the Bank's Share Registrar, F.D. Registrar Services (Pvt.) Ltd, Office # 1705, 17th Floor, Saima Trade Tower - A, I.I. Chundrigar Road, Karachi-74000 (if shares are held in physical form).
