Mandatory Submission of CNIC:

Those shareholders who have not yet submitted a valid copy of their Computerised National Identity Card (CNIC) are once again requested to submit the same immediately to the Share Registrar, M/s. F. D. Registrar Services (SMC-Pvt) Limited, Office No. 1705, 17th Floor, Saima Trade Tower 'A', I. I. Chundrigar Road, Karachi.

Payment of Cash Dividend through Electronic Mode (e-Dividend):

Section 242 of the Companies Act, 2017 requires to the listed companies that cash dividends shall only be paid through electronic mode directly into the bank account as designated by the entitled shareholders.

Therefore, the shareholders are requested to provide complete and correct details of their designated bank account (i.e. Title of Bank Account; IBAN No.; Bank Name; Branch Code; Branch Name and Address; Cell Phone Number; CNIC No. and Email Address) in their CDS accounts through their respective Participants OR CDC Investor Account Services (if shares are held in electronic form) OR to the Share Registrar of the Bank (if shares are held in physical form).
